On **Wednesday, November 30th, 2016** the students in Divisions 9 and 11 will be participating in a field trip to the University of British Columbia, to visit the Museum of Anthropology.

Transportation for this outing will be by First Bus Company. Students are expected to be at the school by 8:30am. We plan on leaving the school at 8:45am and returning by 3:00pm. Students should bring their packed lunches in a clearly labelled, disposable bag and a water bottle. A portion of the field trip will be outside, so students must be dressed appropriately for the weather. The cost per student for this field trip is \$21.00, which includes admission and bus costs.

Supervision will be provided by the school and parent volunteers. Please note, that only a few parent volunteers are required for this field trip as space is limited. Please indicate below if you would like to volunteer. Should we have more volunteers than spaces, we will draw names, and have six parents join us (three per class).
